## Dear GVS Colleagues:

Margaret Tracci (UVA, Charlottesville), Sam Money (Ochsner, New Orleans), Russell Samson (FSU, Sarasota), Matt Corriere (UM, Ann Arbor), and Scott Stevens (UT, Knoxville) delivered incredibly insightful and helpful scientific presentations in the Saturday session; and presentations ranging from governmental relations, health and well-being, patient-centered research, and ethics on Sunday. The panelists interacted fluidly and challenged us all to be the absolute best we can be in our love for and practice of vascular surgery.

The second and third factors which made the meeting so special really go hand in hand, alpha and omega. Sessions devoted to presentations from students and trainees were amazing. The presentations, each delivered with outstanding professionalism, brought new research and challenging cases, and stimulated insightful discussion by surgeons from the audience. Training programs from institutions from all over the state were represented. Congratulations to Dr. Richard A. Meena, Emory University, who won the Robert B. Smith, III, MD Award for Best Resident Abstract Presentation. The meeting closed, in such an appropriate manner, with personal tributes from Dr. Michael Rosenthal to his father, and our first GVS President, Dr. David Rosenthal and from Dr. Will Jordan to his father, Atlanta vascular surgeon, Dr. Daniel Jordan.

So many changes have happened in our society over the past two years. I had the pleasure of serving as treasurer under our 8th President, Dr. Will Jordan in 2020. During that time, we had to be nimble to survive the economic challenges caused by the pandemic. During that time, Ms. Burkhardt and the executive committee, tightened our belt and strengthened our financial position, and updated our website. Dr. Mondy continued that under his leadership.
